You will also be required to pay charges and fees incurred for collection if payments are not made when due. Payments are considered made when received by the Collector. ABATEMENT/EXEMPTION APPLICATIONS: The deadlines for filing applications for an abatement or an exemption from your fiscal year 2024 tax are determined by the date tax bills were mailed, not the date this second payment notice was mailed.
