Built in 1910, 154 East 110th Street is a 4-story walkup apartment building that has 5,992 SF and includes 8 apartments (100% FM) & 1 store. Located between Lexington Avenue and 3rd Avenue, East Harlem is a vibrant neighborhood in Upper Manhattan renowned for its rich Hispanic culture, featuring a mix of tenement buildings, public housing complexes, and newer developments due to ongoing gentrification.

The Property benefits from a Tax Class 2B status which limits annual tax increases to 8% and a maximum increase of 30% over a five-year period.

EAST HARLEM OVERVIEW

East Harlem, commonly known as "El Barrio," is a vibrant neighborhood located in Upper Manhattan. Historically, the neighborhood has been a landing point for immigrant communities, most famously Italian and Puerto Rican populations, which have left a lasting cultural imprint on the area. Today, East Harlem continues to evolve with a mix of long-standing residents and new investment activity, creating a dynamic and diverse urban landscape.

The neighborhood is characterized by a mix of housing typologies, from pre-war walk-ups and tenement-style buildings to larger public housing developments and newly developed residential projects. Over the past decade, East Harlem has been increasingly recognized for its relative affordability compared to adjacent neighborhoods.

Despite ongoing gentrification pressures, East Harlem retains a distinct cultural identity, with its murals, music, and culinary offerings reflecting its Puerto Rican and Latin American heritage. The neighborhood also benefits from proximity to major institutions, including Mount Sinai Hospital and Central Park.

NEIGHBORHOOD ATTRACTIONS AND LIFESTYLE

East Harlem is well known for its cultural and culinary attractions. The neighborhood is home to the Museum of the City of New York and El Museo del Barrio, both of which anchor the northern end of Museum Mile and highlight the city's rich history and Latin American/Caribbean art and culture. Local eateries range from long-standing family-owned restaurants serving Puerto Rican and Dominican cuisine to new cafés, bakeries, and gastropubs catering to a broader audience. Street art and murals can be found throughout the neighborhood, reinforcing East Harlem's identity as a hub of creativity and resilience.

Thomas Jefferson Park, Harlem River Park, and the East River Esplanade provide green space and waterfront access for residents. In addition, Central Park is only a short walk away, offering world-class recreational and cultural activities. Community organizations host annual events and festivals, which continue to foster the neighborhood's lively spirit and cultural pride.

TRANSPORTATION & ACCESSIBILITY

East Harlem is well-connected to the rest of Manhattan and beyond. The neighborhood is served by multiple subway lines, including the 4, 5, and 6 trains running along Lexington Avenue and the 2 and 3 lines accessible just west in Central Harlem. The long-anticipated Second Avenue Subway expansion, once completed, is expected to further enhance East Harlem's connectivity and spur continued economic development. Bus routes also provide extensive crosstown and uptown/downtown service, making the neighborhood accessible for residents and commuters alike.

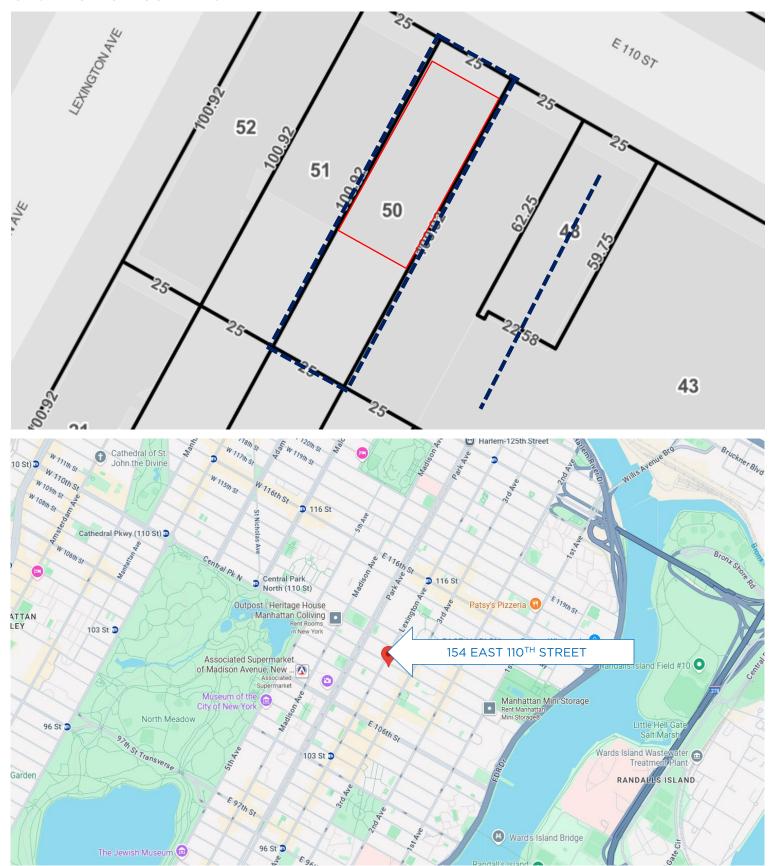
The neighborhood offers immediate access to Harlem River Drive and FDR Drive, connecting quickly to the Bronx, Queens, and downtown Manhattan. The proximity to major thoroughfares and bridges, including the RFK (Triborough) Bridge, makes East Harlem a strategic location for those traveling throughout the city or to regional destinations. These transportation advantages reinforce East Harlem's position as a neighborhood that is both deeply rooted in cultural tradition and increasingly connected to New York City's broader economic engine.
