AMENDMENT NO. 1 TO STORAGE & HANDLING AGREEMENT

THIS AMENDMENT No. 1, (this "Amendment") is dated as of June 20, 2023 (the "Effective Date"), to that certain Storage & Handling Agreement, dated as of May 10, 2023 (the "Agreement"), by and between FRONTIER SCIENTIFIC SOLUTIONS, LLC, a North Carolina limited liability company ("Frontier") and FUSION PHARMACEUTICALS INC., a Canadian corporation ("Depositor"). Section 1.1 shall be amended by deleting the last sentence that states "The first Storage Order is attached as <u>Exhibit A</u>," and inserting the following therein: "Each Storage Order is attached now or later to the Agreement as a separate and independent Exhibit (e.g., <u>Exhibit A</u> is attached to this Agreement)."
 - 2. A new Storage Order is attached to this Amendment as Exhibit B.
- 3. All terms set forth in this Amendment shall have the definitions as set forth in the Agreement.
- 4. All other terms and conditions of the Agreement remain in full force and effect. This Amendment may be executed in identical counterparts, each of which shall be deemed to be an original, and which collectively shall be deemed to be one (1) and the same instrument. In addition, signatures may be exchanged by facsimile or PDF.
