NOTICE OF CHANGE IN ASSESSOR'S IDENTIFICATION NUMBER(S)

This is a notice and not a bill. Periodically it is necessary to change Assessor Identification Numbers (also known as the Mapbook, Page and Parcel). The new numbers identifying your property will appear on your next tax bill.

Sales of portions of the old parcel(s) will be reflected on future tax bills and the correct owner will be billed.

Please refer to this Assessor's Identification Number(s) when making inquiries at the Assessor's Office.

***Explanation of Key:**

- A= Relocations:** A mapbook page number change for your property has required the assignment of the new Assessor's Identification Number.
- B= New Mapbooks:** A mapbook number change for your property has required the assignment of the new Assessor's Identification Number.
- C= Fee to Public/Fee:** A sale/lease, subdivision or combination of parcels has required the assignment of a new Assessor's Identification Number(s).
- D= Public to Public/Fee:** A sale/lease, subdivision or combination of public parcels has required the assignment of a new Assessor's Identification Number(s).
- E= Revision:** The Assessor's Identification Number has been changed due to an engineering correction or revision.
- F= Portion Taken:** The legal description and/or description for the property has changed due to street or alley widening.
- G= Portion Added:** The legal description and/or area description for the property has changed due to street or alley width reduction.
- J= SBE to Other:** Due to a sale or lease termination of a parcel owned or used by a public utility, the State Board of Equalization assessment parcel number has changed to a new Assessor's Identification Number(s).
- K= New SBE:** Due to the sale or lease of your property to a public utility a State Board of Equalization assessment parcel number has been assigned.
- L= TRA Change:** A change in taxing districts has required the assignment of one or more new Assessor's Identification Number(s) to identify your property. The overall total square footage of the property has not been affected.
