The lease has approximately 11 years remaining and six 5-year renewal options with 10% rental escalation in the first option and 5% in each option thereafter. Additionally, the property features a drive-thru pharmacy. CVS Pharmacy is an investment-grade rated company with a Standard and Poor's rating of BBB.

The 8,789-square-foot building is located along Meadow Street a primary thruway in the area. The property features limited competition in the area, as this is the only national drug store within 29 miles. Retailers in the area include Family Dollar, O'Reilly, Subway, Dairy Queen, McDonald's and several others. Other traffic draws through the corridor include the Aitkin Farmers Market, the United States Postal Office, the Aitkin County Fair Grounds, and Aitkin High School. There are 15,782 people living within fifteen miles of the property who earn an average annual household income of \$77,831.













## CITY OF AITKIN, MINNESOTA
